### **REPORT**

#### 1.0 Introduction & Issue to be Addressed

#### 1.1 The writer

I am Miss Philippa Clare Jackson. I qualified in medicine in 2006 (GMC 6143070) and entered the field of Plastic and Reconstructive Surgery in 2011. I completed specialist training in 2018 and became a substantive consultant the same year. I am a Fellow of the Royal College of Surgeons of England (Plastic Surgery) and am on the General Medical Council Specialist Register for Plastic Surgery. I am a Consultant Plastic Surgeon with subspecialty interest in Oncoplastic and Breast Reconstruction. Part of my responsibilities include the treatment and care of patients with soft tissue injuries.

I have a BSc in Healthcare Ethics and Law from King's College London (2004). I have completed the Royal College of Surgeons of England course 'Legal Aspects of Surgical Practice', and a course on writing medicolegal reports accredited by the Royal College of Surgeons of England. Full details of my qualifications and experience entitling me to give expert opinion can be found in Appendix 1.

# 1.2 Summary Background of the Case

I have been asked to provide a report by , on behalf of the instructing solicitor , in relation to injuries sustained by that occurred on . I have been specifically asked to include in my report an assessment of pre-accident medical history, injuries sustained, treatment received and present condition. I have been asked to comment on the capacity for work and give a prognosis. I was asked to interview and examine the claimant, and comment where appropriate on the medical records provided to me (see Appendix 2).

## 1.3 Summary of My Conclusions

The following has been summarised from supplied medical notes and interview with the claimant.

It is my opinion that sustained a laceration to the **vertex** of the scalp resulting in a scar on this was caused by a piece of wood falling on him at work and this is consistent with the injury.

scar is permanent, and improvement is unlikely in the future without surgical or non-surgical intervention.

### 4.0 Accident Details

#### 4.1 Accident summary

Whilst at work was moving a pallet which was supporting some wood he was spraying. The wood fell and hit on the head causing a laceration to the scalp.

had pressure applied to his wound and he was taken to hospital by one of the managers. He did not lose consciousness. was not wearing any protective head gear. 4.2 Injuries/Symptoms sustained a laceration to the scalp. also complains of symptoms related to a head injury which has been the subject of another report [ report]. suffered a strain to his neck which has been the subject of another report report]. 4.3 Treatment received received first aid in the form of pressure with a rag at the time of the injury. attended where he had the wound cleaned and sutured. subsequently attended and underwent a CT scan of his head. GP removed the sutures on . He estimates healing took 2 weeks. 4.4 Medical records review Review of the GP medical records revealed a history of asthma for which takes inhalers and depression in the past. He is an ex-smoker. He has recently suffered a deep vein thrombosis and is taking anti-coagulants. There is no other medical history of note. 4.5 **Examination findings** has a linear scar running parallel to the midline on the left side of the vertex of his scalp in a sagittal plane. The scar was measured today as 4cm in length. The scar is thin and white in appearance. scar sits in an area of relatively sparse hair coverage and is therefore easy to see when he is in a seated position. The scar is well healed. tells me the surrounding skin has normal sensation and it is pliable.

The scar has a stepped feel with one edge sitting higher than the other.

may benefit from a period of scar therapy. A new appointment with a scar therapist would cost approximately £100. A follow-up appointment would cost approximately £50.

#### Scar revision

If the uneven nature of the scar bothers he could undergo scar revision under a local anaesthetic. There is a risk that the scar is the same or worse after the procedure. The surgery would cost approximately £750-£1000. Other risks include bleeding, infection, stretched scar, and ongoing lumpiness.

# 3 Glossary of Technical Terms


Sagittal

The sagittal plane is an anatomical descriptor. It runs from front to back as shown in the image below and divides the body into a right and a left side.
